Until December 2011 in order to satisfy anticipated exercises of options under the 1993/2003 UK Sharesave Scheme and the 2003/2013 UK Sharesave Scheme (the “Schemes”), new ordinary shares were from time to time issued by the Company and allotted to Prudential QUEST Limited, thereby increasing the Company’s issued ordinary share capital.**

**From December 2011 new shares will be issued when options under the Schemes are exercised. Thus, the exercise of an option under the Schemes will increase the Company’s issued ordinary share capital.**
