New ordinary shares are issued when options are exercised under the schemes in Section III, item 1
(the "Scheme"). Thus, exercises of options under the Scheme will increase the Company's issued
ordinary share capital.
In order to satisfy anticipated exercises of options under Section III, item 2, the 2011/2021 Prudential
International Savings-Related Share Option Scheme (the "ISSOS"), and to satisfy anticipated releases of
shares to participants following the vesting of awards under Section III, item 5, 2013 Prudential Long
Term Incentive Plan (the "PLTIP"), new ordinary shares are from time to time issued by the Company
and allotted to Sanne Fiduciary Services Limited, thereby increasing the Company's issued ordinary
share capital. These shares are held by the Prudential Employee Share Trust on behalf of the participants
of the ISSOS and the PLTIP, and released to them when they exercise their option or their awards vest
where relevant.
In order to satisfy anticipated exercises of options under Section III, item 3, the 2012/2022 Prudential
International Savings-Related Share Option Scheme for Non-Employees (the "ISSOSNE"), and to satisfy
anticipated releases of shares to participants following the vesting of awards under Section III, item 4,
2011 Prudential Agency Long Term Incentive Plan, new ordinary shares are from time to time issued
by the Company and allotted to Asian Agency SPV Limited, thereby increasing the Company's issued
ordinary share capital. These shares are held by the Prudential Agent Share Trust on behalf of the
participants of the ISSOSNE and the Agency LTIP, and released to them when they exercise their option
or their awards vest where relevant.
