Prudential plc (the “**Company**”) announces today it has purchased the following number of its ordinary shares of 5 pence each through Barclays Capital Securities Ltd (the “**Bank**”) on the London Stock Exchange in accordance with the authority granted by shareholders at the Company’s 2023 Annual General Meeting (the “**Purchase**”). The Purchase was effected in accordance with the non-discretionary agreement entered into with the Bank, as announced on 5 January 2024.

Aggregate number of ordinary shares purchased: 360,000 (ISIN GB0007099541)

The Company intends to cancel the purchased shares. Following the above transaction, the Company will have 2,752,329,140 shares in issue.

All shares were purchased from the Bank as an on-exchange transaction subject to the rules of the London Stock Exchange and the Hong Kong Code on Share Buy-backs.
