Sharesave Scheme and the 2003/2013 UK Sharesave Scheme (the "Schemes"), new ordinary shares are from time to time issued by the Company and allotted to Prudential QUEST Limited, thereby increasing the Company's issued ordinary share capital. No new shares are issued when options under the Schemes are exercised. At the time of exercise existing ordinary shares held by the Prudential QUEST Limited are transferred into the name of the person exercising the option. Thus, the exercise of an option under the Schemes has no effect on the Company's issued ordinary share capital.

Section III, items 6 and 7. The 2006 Group Performance Share Plan and Business Unit Performance Plan are discretionary share plans and not share option schemes. However, for the sake of completeness the figures are included in Section III as new shares are issued in order to satisfy awards. In order to satisfy anticipated releases of shares to participants following the vesting of awards under the 2006 Group Performance Share Plan and Business Unit Performance Plan, new ordinary shares are from time to time issued by the Company and allotted to the BWCI Employee Benefit Trust, thereby increasing the Company's issued ordinary share capital.

No new shares are issued on release of shares to a participant under the 2006 Group Performance Share
Plan and Business Unit Performance Plan. At the time of release existing ordinary shares held by BWCI
Employee Benefit Trust are transferred into the name of the participant. Thus, the release of shares
following the vesting of awards under the 2006 Group Performance Share Plan and Business Unit
Performance Plan have no effect on the Company's issued ordinary share capital.
