Until December 2011 in order to satisfy anticipated exercises of options under the 1993/2003 Prudential Savings-Related Share Option Schemes and the 2003/2013 Prudential Savings-Related Share Option Schemes (the “Schemes”), new ordinary shares were from time to time issued by the Company and allotted to Prudential QUEST Limited, thereby increasing the Company’s issued ordinary share capital.

From December 2011 new shares are issued when options under the Schemes are exercised. Thus, the exercise of an option under the Schemes will increase the Company’s issued ordinary share capital.

Section III, items 6, 7 and 8. The 2006 Prudential Group Performance Share Plan, Prudential Business Unit Performance Plan and Prudential Agency Long Term Incentive Plan are discretionary share plans and not share option schemes. However, for the sake of completeness the figures are included in Section III as new shares are issued in order to satisfy awards. In order to satisfy anticipated releases of shares to participants following the vesting of awards under the 2006 Prudential Group Performance Share Plan and Prudential Business Unit Performance Plan, new ordinary shares are from time to time issued by the Company and allotted to BWCI Trust Company Limited, thereby increasing the Company’s issued ordinary share capital.
